**CE-MARKING APPLIES TO:**

- Vessels placed on the EEA-market after 16 June 1998
- Engines placed on the EEA-market after 1 January 2006

Kindly note that Documents of Compliance will be required sent to the Ship Registers for vessels and engines bound for CE-marking. The documents will be used for control of vessel's measurements, identification of the vessel as well to ensure that the necessary documentation exists.

The Norwegian Maritime Directorate is, however, still the regulatory authority for the vessels and controlling body for CE-documentation. Kindly direct all enquires regarding CE-marking etc. to the Norwegian Maritime Directorate.
